
#### **HEALINT Outputs**

- **HEALINT PROTOCOL** creates the possible criteria for selection of placements for trainees. The audit protocol will ensure that when a student requires an international placement, the home organisation (which must meet national requirements) will be able to check and assure the quality of the placement offered by a host (whose standards may be very different).
- HEALINT QUESTIONNAIRE/INSTRUMENT and GUIDELINES (on how to use the checklist)
- HEALINT AUDITOR Training
- **HEALINT EVALUATION TOOL**, identifying metrics which determine whether the conclusions drawn from the initial audit can be predictive of high quality placement learning environments. This will triangulate the prospective quality process proposed by looking at retrospective evaluation processes.
- HEALINT Monograph on Transferability

#### The HEALINT PROTOCOL

- The Healint Protocol For Quality assurance, Appraisal and Audit of Institutions and Practice Settings: The protocol creates the possible criteria for selection of placements for trainees.
- The Protocol is:
  - An evidenced and agreed set of standards to be addressed when developing and implementing education for clinical care workers within clinical learning environments
  - Able to be used with Audit Tools to support quality enhancement and assurance
  - Currently focused upon Nursing and Midwifery but with wider potential
  - Evidenced using global and EU Literatures, databases and regulations
  - Agreed as compliant by partners Expert reviewers and Global Experts
  - A Document with Transnational capability

#### **Tool for Post-Evaluation of Placement Quality**

- Underpinned by metrics and evidence based tools and literature (eg CLES-T, partners' student evaluation tools and partners' tools for the educators' evaluation)
- Built around partners' consensus discussions and international students' feedback
- Design: questionnaire with 62 quick questions, easily answered once students end their practical learning in one setting.
- Piloting Evaluation: directly with former international students and comparing with those students' evaluation reports.





#### **Rationale and Objective (WHY)**

- The HEALINT Protocol was initially designed having the needs of nurses' traineeships in mind and tested in a short sample of European countries (Finland, Spain and UK). However, it showed potential to add value to traineeships in other healthcare sectors and other countries around and beyond Europe.
- To confirm this potential, a needs analyses was needed to identify the adaptations necessary to be made to the HEALINT Protocol in order to boost its uptake around the world and ISO offered the perfect quality infrastructure to do so.



#### **Development/Implementation (HOW)**

- The HEALINT consortium partnered with British Standards Institute (BSI), the national standardization body in UK and an ISO member. BSI submitted the HEALINT Protocol content as a draft proposal for the development of a new International Workshop Agreement;
- Following ISO approval, **88 Experts, representing 63 organizations from 23 countries** actively participated to discuss, line by line, the contents of the HEALINT Protocol, **reaching international consensus** on the contents of <u>IWA 35:2020 Quality of learning environments</u> for students in healthcare professions Requirements for healthcare education providers in care settings, which was published by ISO on November 17, 2020.



#### **Outcomes/Results (WHAT)**

- The expected outcomes of the handover to ISO is a wider and boosted dissemination and adoption of the HEALINT Protocol, through its improved version renamed <a href="IWA 35:2020-Quality of learning environments for students in healthcare professions — Requirements for healthcare education providers in care settings">settings</a>.
- ISO mapped IWA 35 as contributing to the following <u>United Nations Sustainable development</u> <u>Goals</u>:
  - 3 (Good Health and Well-Being)
  - 4 (Quality Education)



#### **Future Challenges (NEXT STEPS)**

- As an IWA is a standardization deliverable that can only be revised once and each version can last only for two years, after testing the market the envisioned path is to review and upgrade IWA 35;
- We will, again, use an applied research project to prepare this revision:
  - New Project HEALINT4ALL funded for three years to determine wider applicability of HEALINT Protocol and ISO IWA 35 for Medicine and Physiotherapy
  - Will develop digital resources for teaching and audit relevant for Nursing, Midwifery, Physiotherapy and Medicine
  - Will expand the protocol languages used to add in Greek to four existing languages (Spanish, Finnish, Polish and English)
